

Terms and Conditions

1. This promotion is valid for purchase of NESTLÉ OMEGA PLUS products, i.e. OMEGA PLUS Milk with Oats 10x42g, OMEGA PLUS ACTICOL 1.2kg, OMEGA PLUS ACTICOL 1kg, OMEGA PLUS ACTICOL 600g and OMEGA PLUS ACTICOL Stick Pack 15x31g from 7 October 2017 to 30 October 2017 (both dates inclusive, the "Promotion Period").

2. Participants who purchase:

(a) 2 packs of OMEGA PLUS Milk with Oats can redeem a free Luminarc portable tempered glass jar worth S\$23 (manufacturer's recommended retail price); OR
